

## Dementia Care Aware

### **Presented by:**

University of California, San Francisco

### **Educational Goals**

This training is designed to increase the detection of dementia in a primary care setting. Future trainings will help providers improve the clinical staging and documentation of care planning for patients living with dementia, and increase provider self-efficacy in detecting and diagnosing neurocognitive disorders. Dementia Care Aware will inform providers on how to improve the continuity of care via longitudinal relationships with patients and caregivers, the coordination of care via referrals to resources and services, and the comprehensive care provided by improving providers' ability to recognize cognitive impairment at the onset.

### **Educational Goals**

At the end of this activity, the participant should be able to:

1. Understand how to detect cognitive impairment early on and the importance of doing so.
2. Conduct, score, and interpret two cognitive screening tools (Mini-Cog and GP-Cog[1] ).
3. Make appropriate referrals (and bill for the screenings using a new code).

### **Courses Available**

4. Conducting the CHA: The Basics (core module).

### **Educational Goals**

Participants should complete the Conducting the CHA: The Basics eLearning course, answer the multiple-choice test questions, and complete the evaluation form online to receive a certificate.
